# 1. CALL TO ORDER

The meeting was called to order at 1300 hours.

P. Novak-Cawley welcomed Christian Gonzalez and Penny Gallagher to the meeting. She introduced Christian Gonzalez as a new member to Education Council representing the student community.

It was noted that the sentence stated in 4c(i) on page 3 of the draft minutes should read "... There were also changes to reflect the credits awarded for some Science courses at Langara."

#### 4. CURRICULUM

# 4k) SOCIOLOGY/ANTHROPOLOGY

**New Course Proposal** 

# i) ANTH 1224 – Ethnoarchaeology

M. Gerson introduced M. Chapman-Kendall, instructor in the Anthropology department, and invited her to present the new course proposal. M. Chapman Kendall thanked the Education Council members for agreeing to shift the agenda to accommodate her schedule. She advised that ANTH 1224 (Ethnoarchaeology) is a new course developed to augment the Anthropology Field School offering; yet, it is not limited to being offered in the field. Tanja Hoffman, who is the instructor for this course, has put together the course package. This course will be offered in summer 2004 in conjunction with the Archaeology Field School, which will be in Pitt Meadows. She requested that the following sentence be added to the calendar description:

"A variety of methodological and theoretical perspectives will be considered."

**MOTION:** That the new course, ANTH 1224, be approved with the above sentence added to the calendar description.

#### 4a) ABORIGINAL STUDIES

**Program Revision** 

# i) Aboriginal Studies

M. Gerson presented this program revision in B. Pendleton's absence. He indicated that the five Aboriginal Studies courses, which replaced the courses previously offered at the IIG (Institute of Indigenous Government), with which Langara partnered until last spring, had already been approved by Education Council in June 2003. These courses have been listed on our website since last summer and the courses were offered last fall. The changes made to the program, however, were not previously presented to Education Council for approval. Therefore, this revision is being made to accurately reflect practice.

**MOTION:** That this program revision be approved as presented.

# 4c) BUSINESS MANAGEMENT

**Change to Course Prerequisite** 

# i) BUSM 2150 - Credit & Collection Management

L. Cullen advised that BUSM 2150 was part of the Business Management program and it has now become an elective. Students enrolled in the course do not have the same program background; thus, the success rate has decreased. Therefore, the Business Management department is requesting the addition of the following prerequisite:

BUSM 1100 'C-'

**MOTION:** That this change to course prerequisite be approved as recommended.

#### **New Course Proposals**

- i) COOP 1000-1499 COOP Internship Work Placement Performance
- ii) COOP 1500-1999 COOP Internship Work Placement Report
  - L. Cullen presented these two new course proposals.
- i) COOP 1000-1499 COOP Internship Work Placement Performance She advised that Co-op department has developed this proposal to provide a co-op option for students who are not in a co-op program but are motivated to participate in a work term to gain their career-related work experience. This course also gives the students the co-op credit required to be hired by an employer who wants to or can only hire a co-op student for a position. The course number will begin sequentially from 1000-1499.
- ii) COOP 1500-1999 COOP Internship Work Placement Report These courses involve the preparation of the work term report, which is evaluated by the cooperative coordinator, faculty and in some cases by the employer.

**MOTION:** That these two new course proposals be approved as recommended.

### **Change to Course Prerequisite**

#### iii) COOP Programs

- L. Cullen presented this change to course prerequisite. The Co-op department requested changing the admission requirements for all Cooperative Education Diploma Programs to read:
  - "Be enrolled in 3 program courses (minimum 9 credits) or more, not including BUSM 1310."

**MOTION:** That this change to course prerequisite be approved as recommended.

# 4f) ECONOMICS

**Change to Course Prerequisite** 

# i) ECON 2296 – Managerial Economics

M. Gerson advised that ECON 2296 is a second-year economics course that is required by most university transfer commerce students. The Economics department requested changing the prerequisite from:

"ECON 1220 and 1221, MATH 1153 and 1171 and 1173, 1174 or 1274, all with a 'C' grade or higher" to

"ECON 1220 with a 'C+' grade or higher and ECON 1221 and MATH 1153, or 1171, or 1173, or 1174, or 1253, or 1271, or 1273, or 1274 with a 'C' grade or higher"

A question was raised whether this change might affect the admission requirements to the Commerce Transfer program. M. Gerson suggested that L. Cullen check with E. Hamer.

**MOTION:** That this change to course prerequisite be approved as recommended.

#### 4g) FILM ARTS

#### New Program Proposal

#### i) Film Arts

D. Steeves presented this new program proposal. The proposal was originally presented to Education Council in September 2001 as "Studies in Acting, Writing & Design for the Screen". He advised that a survey has been conducted and he reviewed the results. The results indicated that students show more interest in a directing component than in the original screen design proposal. As a result, it was proposed to substitute the "Design" certificate with a "Directing" certificate and that Langara call the new program "Film Arts". He indicated that there is a change in the student capacity from 42 to 39 on page 49 of the agenda package. He also distributed revised copies of the calendar description (p. 55-58) that will replace the existing pages in the agenda package, noting the minor wording changes were reviewed by the Dean and the Registrar's office.

It was pointed out that students who wish to obtain a second certificate in another stream of the Film Arts program must repeat FLMA 1180 and FLMA 1280. Since the same course number would appear as a duplicate course on student's transcript, it was recommended that the program identify each individual course with a different number.

M. Gerson suggested that this proposal be approved subject to allowing the Film Arts program and the Registrar's office to work out an appropriate numbering system for the courses, and make changes to the course numbers within the spirit of the description that appears on page 55 of the calendar description.

**MOTION:** That this new program proposal be approved with the above recommendation.

# 4h) FINANCIAL MANAGEMENT

**Change to Course Prerequisite** 

#### i) FMGT 1323 – Management Accounting I

L. Cullen presented this change to course prerequisite. The Financial Management department requested adding FMGT 1115 as a prerequisite to this course.

**MOTION:** That this change to course prerequisite be approved as recommended.

**Discontinued Course Request** 

# i) POLI 2242 – Sustainable Development

M. Gerson advised that this was one of the courses in which students were required to register at Langara for the Africa Field Study program. Since the program is now delivered through McGill University, the History/Latin/Political Science department requested discontinuing the above course.

**MOTION:** That this request to discontinue POLI 2242 be accepted as recommended.

#### 4j) MATH & STATS

**New Course Proposal** 

# i) STAT 1182 – Using EXCEL in First Term Statistics

M. Heldman presented this new course proposal. The Statistics department has developed STAT 1182 to retain transferability with SFU. SFU has changed its requirement to include an additional credit, namely the use of Excel in Statistics. Students who wish to transfer to SFU are, therefore, required to take both STAT 1181 and STAT 1182. M. Gerson advised that this course will be made available to students beyond Langara through BC Campus and that the prerequisite for STAT 1182 will be STAT 1123 or 1124 or 1181 or permission of the department.

**MOTION:** That this new course proposal be approved as recommended.

Minor Course Revision

# i) CPSC 1050 – Introduction to Computer Science

# ii) CPSC 1280 – Principles of Operating Systems

M. Heldman presented these two minor course revisions as a package. The Computer Science department proposed to make minor changes to the course title and description to reflect the course delivery and topics covered.

**MOTION:** That these minor course revisions be approved as recommended.

# iii) CPSC 2810 – Computer & Information Security

M. Heldman advised that CPSC 2810 is a new course developed to address security issues in computing. The College has worked in conjunction with the Computer Science department to ensure that this course is offered in a hardware lab isolated from the other common areas. The first course offering will take place this summer.

**MOTION:** That this new course proposal be approved as recommended.

#### 5. FINAL EXAM STATUS

M. Gerson stated that the Final Exam Status, which was approved by Education Council, has now been revised incorporating the changes raised at the last meeting. He suggested that this list be accepted as presented and any future changes need to go through division chairs' office to be presented at the DDC and Education Council for approval. This list will be updated on a regular basis to reflect any changes made to the status of the courses. It is the role of the division chairs to enforce this list and notify instructors that they have to follow the appropriate process, as approved by Education Council, to change the examinable status of a course.
